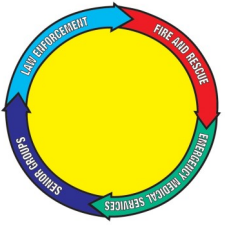

## Hurstbourne Acres is now a **Yellow Dot** program provider!



The best chance for survival following a traumatic injury occurs when the injured person is seen and treated within an hour of the event. In the moments directly following a crash, seconds count.

Participants are providing important medical information that could help emergency responders make split second decisions.

This is how the program works....

- The Yellow Dot decal is placed in the lower-left corner on the driver-side rear window. Make sure the glass surface is clean so the decal will adhere.
- A Yellow Dot personal information folder is placed into the glove compartment of the vehicle. The completed form should include a clear, close-up face shot picture that can be easily identified as the crash victim.
- Make sure it is on top of other papers, and readily visible to first responders.
- If there is more than one person who uses the vehicle, or if you routinely carry children in the vehicle, consider including a separate Yellow Dot folder for each regular occupant. Keep all Yellow Dot folders together in the glove compartment to make retrieval in an emergency faster.
- The form itself includes basic medical and emergency contact information, personal physician's contact information, current medical conditions, allergies and medications, and a history of recent surgeries. To help protect your identity, **don't** include information like credit card or social security numbers.

The program is a free service provided to all Hurstbourne Acres citizens, provided through the Kentucky Office of Highway Safety.

## **July Message from Police Chief Steve Griffin**

More and more we hear about data breaches of some major government organizations and global businesses, where personal data has been stolen. It's a scary thought. Whether it's the IRS, Anthem, the VA or banking & financial institutions, we depend on these people to keep our information secured, but when they fail, we often end up paying the price.

Identity theft is a major issue for law enforcement and it's very difficult to solve or prosecute. The difficulty in dealing with these issues is that much of the identity theft occurs over the Internet, from perpetrators in other countries, where U.S. law enforcement does not have jurisdiction.

And if that's not enough, once you have become a victim, it's up to you to file dispute after dispute, file reports, and get signed copies of affidavits in an attempt to prove you are not responsible for the many bills that have been racked up using your stolen information. Many people have suffered huge losses due to these thefts and spend many years trying to recover.

What should you do if you believe you are a victim of identity theft? First and foremost, report it to local law enforcement and at [IdentityTheft.gov](http://IdentityTheft.gov). Contact one of the three credit bureaus and have a fraud alert placed on your information. Order a free copy of your credit report. File disputes on any credit discrepancy.

Contact the Federal Trade Commission at: [FTC.GOV/IDTHEFT](http://FTC.GOV/IDTHEFT). When dealing with these issues, make sure to keep copies of any and all correspondence for your personal records.

We encourage you to review your free credit report at least once a year. We also highly encourage our residents to contact the Police department whenever you see something suspicious.

### May 19, 2016 Minutes

After a discussion about the errors in the printed copy of the newsletter/minutes, Commissioner Renninger made a motion to accept the minutes as shown on the City's website. The motion was seconded by Commissioner Nichols and carried unopposed.

Commissioner McAllister requested that Sara Brown ask the vendor of the printed copy for a credit as a result of the errors.

### Treasurer's Report

Treasurer Sharon Hollkamp read the monthly treasurer's report for May, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner Renninger made a motion to accept as reported. Commissioner Eskridge seconded the motion which then carried unanimously.

### Warrants

Treasurer Sharon Hollkamp read the warrants for May, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner McAllister made a motion to accept as reported. Commissioner Renninger seconded the motion which carried without opposition.

### Attorney's Report

Andrew Howell from the office of our city attorney had nothing new to report.

### Police Report

Police Sergeant Flowers reported the following for May;

### May Highlights;

- All officers completed KLC recommended monthly training,
- 1 offense report was for a theft of a case of cigarettes from Speedway, and the other 3 involved thefts from vehicles on Haviland and the Meadows Apartment Complex.
- Directed patrol was for traffic concerns on Cardwell,
- Department supported the city yard sale,
- All Golden Watch residents checked weekly,
- All businesses in the shopping centers checked daily,
- Explorer and Impala are in good working order.

### COMMITTEE REPORTS

#### Parks

Commissioner Eskridge advised that the 12 trees for the park have been delivered. The cost of the trees is around \$1900, and the grant money for the trees is \$1750. It was suggested that the City use gators (drip irrigation bags for tree care) which will be covered with mulch. The bags will require filling once per week.

In other news, signs outlining the park rules have been posted. Also, the date for the city picnic will be announced at next month's meeting. A new quarterly report for the park will be provided, and by all accounts, the city wide yard sale was a success.

#### Sanitation

Commissioner McAllister stated that he has not received a reply to an e-mail sent to Attorney Emery requesting advise on the Blowing Tree sidewalk project. The owners of the Meadows Apartments still have not formally approved or rejected the construction of a sidewalk. Attorney Howell said that if a copy of the e-mail can be forwarded to him, he will get Commissioner McAllister a reply before Attorney Emery returns. Mayor Fore also requested a copy of the e-mail.

E-Cycle is returning to the City on August 6 between 9:00 am & 11:00 am. They will set-up at the usual location, the corner of Addington & Haviland. More detailed information about what items they will accept will be provided in the City newsletter.

A resident made a complaint about emptying of dumpsters behind Pier One before 6:00 am by Eco-Tech. Commissioner McAllister had spoken to the Eco-Tech manager, but the problem continued. Mayor Fore suggested that he contact the president/owner of Eco-Tech to resolve the issue.

The 'Yellow Dot' program was discussed. It is a Kentucky Highway Safety Department initiative by which a yellow sticker on the back window of your vehicle informs first responders that pertinent medical information is located in the glove compartment. Mayor Fore recommended that Commissioner McAllister write an article for the Hurstbourne Acres Post describing this free, voluntary program and to make residents aware of this option. In answer to a question from a resident who asked whether this could be used at your home,

### **Sanitation (cont.)**

Commissioner Eskridge advised that the Fire Department already has a program like this for homeowners.

Commissioner McAllister has been seeking bids for having city entrance signs refurbished, but has not yet received any quotes.

### **Roads**

Commissioner Nichols reported that the new park sign has been installed. The installation of the new street signs should begin within the next 2 weeks. Finally, regarding the reference to the City's nuisance ordinance in the last newsletter, the Commission requested that a copy of the ordinance be added to the website.

### **Police**

Commissioner Renninger reported that the ABC license renewals have been sent to the pertinent businesses in the City. The City is getting notices about the nuisance ordinance. Nunnlea has hired someone to repair a wall, and Commissioner Renninger will be here on those 3 days it will take to complete.

On July 23 at 1:00 pm, the City is sponsoring a Gun Safety Workshop. Free gun locks will be available. In October, the City is planning a joint workshop with Nunnlea.

### **Miscellaneous**

Mayor Fore said that he has not heard anything more regarding help with removing the logs at the end of Blowing Tree. He had contacted attorney, Jim Lobb, who was asked to contact the attorney for the new apartments at the end of Bunsen. In other news, a resident asked the Commission whether we had contacted the owners of the new apartments to determine any interest in becoming a part of our City. Attorney Howell advised that unless our City can provide a service that Louisville Metro cannot currently provide, the chance of annexing would be improbable.

There being no further business or discussion, the meeting was adjourned.
