# October Message from Police Chief Steve Griffin

I hope that everyone is doing well and enjoying the beginning of autumn. I have several issues that I'd like to address this month. As many of you may know, there were several garages and vehicles broken into over the Labor Day weekend. Many of these incidents were reported promptly the next day but, over the course of the following week, there were several residents that mentioned that their vehicles had been gone through but they didn't report it. I would ask all of our residents to please report any incidents of this nature to the police department as soon as you become aware of them. They may seem trivial and oftentimes nothing can be done, but in some cases it is the small things that can help us to link a suspect to a crime. Keeping our city safe requires a partnership and as always, we appreciate your help.

We have also been receiving numerous complaints from residents in reference to traffic issues in the neighborhood. There have been problems with speeding and failures to stop for stop signs at the intersections. Some of these issues are being caused by persons passing through the neighborhood but oftentimes I have also observed residents pushing the envelope on these issues. As a reminder, the speed limit on all residential streets is 25 miles per hour unless otherwise posted, and coming to a full and complete stop is required at all stop signs. You will be seeing increased enforcement activity in the area so please make your friends and family aware of these issues. Citations for these violations carry fines and court costs of approximately \$150.00 so please drive safely.

Lastly, don't forget that Halloween is coming up this month. Please be cautious during times when children will be out Trick or Treating. If you will be escorting children, while they are out, please follow safety precautions when choosing costumes and make sure that you have adequate lighting and supervision to keep your little superheroes, monsters, princesses, and pirates safe.

- Registered voter temporarily living in another state
- Incarcerated (but not convicted of a felony)
- Participant in Secretary of State's address confidentiality program

Qualified voters may pick up their absentee ballot application, in person, at any Jefferson County Clerk's Motor Vehicle Office, otherwise only the voter or the voter's spouse, parent or child can request an application for a mail-ing absentee ballot. Both the application & the ballot can only be mailed directly to the voter.

The regular meeting of the City Commission was called to order at 6:30 PM on September 8, 2016 at the meeting room of the Hurstbourne Acres City Hall/Police Department, 1916 Hurstbourne Circle, Louisville, Kentucky, with the following persons present;

#### August 18, 2016 Minutes

After a discussion, Commissioner Nichols made a motion to accept the minutes as published. The motion was seconded by Commissioner Renninger and carried unopposed.

#### <u>Treasurer's Report</u>

Sharon Hollkamp read the monthly treasurer's report for August, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner McAllister made a motion to accept as reported. Commissioner Eskridge seconded the motion which then carried unanimously.

#### <u>Warrants</u>

Sharon Hollkamp read the warrants for August, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner Eskridge made a motion to accept as reported. Commissioner Nichols seconded the motion which carried without opposition.

#### Police Report

#### August Highlights;

-All officers completed KLC recommended monthly training,

-2 offense reports were for a burglary in the Meadows Apartments, and a theft from a vehicle in the East Chase Apartments,

-The directed patrol was for reported minor vandalism in Cherry Springs Apartments, Police Chief Criffin attended the KV

-Police Chief Griffin attended the KY

Association of Chiefs of Police Conference, -All Golden Watch residents checked weekly,

-All businesses in the shopping centers checked daily,

-Explorer is in good working order, and the Impala suffered a major mechanical failure. It will be taken out of service. The new vehicle is in the process of being equipped for service.

In answer to a question from the commission, Chief Griffin confirmed that there were 6 vehicles broken into on Labor Day (Hurstbourne Circle & Addington Ave). The suspected perpetrator(s) have been arrested.

#### Attorney's Report

Steve Emery is working with the Commission on the recent nuisance filing mentioned in last month's meeting. Also, his office continues to assist with the progress of the sidewalk project on Blowing Tree Rd. A written determination for the Impala has been prepared so that it might become surplus property which can then be handled accordingly. Finally, a draft copy of a 'Vacant Property' ordinance was provided to the Mayor. In order to give time for all commissioners to review, the first reading will be postponed until the October meeting.

## **COMMITTEE REPORTS**

#### <u>Parks</u>

Commissioner Eskridge advised that the GFIC outlet in the landscaping bed of the main entrance sign on Hurstbourne Lane has been repaired. Regarding the invasive vines on the Bunsen Parkway berm, the 2 specialist who have examined the impacted trees declined the job due to the difficulty of remediation. A decision was made to defer any further action until after the picnic. Lastly, all of the plans and arrangements for the picnic are complete, and under budget.

#### **Sanitation**

Commissioner McAllister is waiting for updated information from our city attorney's office concerning the sidewalk project on Blowing Tree Rd. The repair or

refurbishing of the city entrance signs and surrounding shrubs was again mentioned. The commission agreed that any action would be delayed until after the city picnic. Commissioner McAllister brought up the possibility of having surveillance cameras installed in the City. It was noted that this idea was suggested years ago, only to be eventually rejected. After a discussion, Mayor Fore asked him to do the research and report back with more specifics at a future meeting. Finally, resident Marty Dunn said that he noted a couple of incidences in which Eco-Tech dumped recycling along with regular garbage in the same truck. Commissioner McAllister said that he would call them with the City's concerns (violation of the contract), and to prevent its recurrence.

#### <u>Roads</u>

Commissioner Nichols reported that LG&E had contacted her for a list of the streets in our City. This was in response to the work order that was filed to have the light poles repainted. The suggestion from the inquiry was that the painting of the light poles will be done sooner rather than later though no specific date or dates were provided. Mayor Fore also noted the need to repair a street light that had been knocked over on Hurstbourne Lane. Finally, all of the shrubs in front of the city entrance signs will be replaced sometime after the picnic as previously noted.

#### **Police**

Commissioner Renninger reported that she has received complaints from residents about other residents driving too fast in the City. Mayor Fore asked simply that our police officers enforce the posted traffic control devices. In other news, it was mentioned that the City's new police vehicle is a 2016 Ford Taurus, and the Impala will be auctioned off. Mayor Fore then read the written determination form allowing the Impala to be reclassified as 'surplus property' to which the commission agreed unanimously. The emergency equipment is being removed from the Impala. Lastly, Commissioner Renninger advised that she contacted the same vendor as last year to provide snow removal this year. The cost has not changed.

#### <u>OLD/NEW BUSINESS</u> Kentucky Open Records/Open Meeting Act

Mayor Fore distributed a new signature form. As required by law, whenever there is a change in legislation, the Attorney General sends to each city mayor a requirement to deliver to their city officials a new form. This form provides proof of receipt that all appropriate city officials acknowledge through their signature, and is kept on file with the city clerk.

#### **Election News/Forum**

Mayor Fore asked the commission and those in attendance whether there is an interest in continuing the practice of having a forum for those running for office.

#### **Election News/Forum (cont.)**

After a discussion, it was agreed that the City will again host a forum and that it will take place between the October meeting and election day, 11/8. Doug Rogers, the Ethics Committee Chairman, was proposed as moderator. Commissioner McAllister will check with him and verify his interest. More specifics will be included in the upcoming newsletter.

#### Vacant Property

A resident asked about a vacant property on Taylorsville Road. It was stated that the property is not being maintained, specifically mentioning the overgrown backyard and the uncovered pool. Mayor Fore said that he would have one of our police officers check further and report.

#### Nuisance Ordinance Complaint

Mayor Fore read the letter he wrote to the owners of the property at 9108 Hurstbourne Lane concerning the violations of the 'nuisance' ordinance. The letter was sent by certified mail today.

#### Curb Maintenance

Resident Lenny Miles observed that some corner lot owners are not maintaining the curb area, allowing grass/ weeds to grow taller than the ordinance allows. He asked if this could be mentioned in the newsletter to encourage compliance. Mayor Fore said he would first meet with him to get more detailed information (addresses in particular).

There being no further business or discussion, the meeting was adjourned.


