November 2016 Message from Police Chief Steve Griffin

We are quickly coming into the holiday season and many of you will be traveling to visit family and friends over the next few months. As you plan your holiday travels, I'd ask that you please plan ahead and pay attention to these two issues.

First, make sure that your vehicle is ready for the inevitable winter weather that will be upon us before we know it. At a minimum make sure to check your battery, tires (to include the spare), windshield wipers, and anti-freeze levels. It is also a good idea to keep some additional items in your vehicle in case of a break down or getting stuck out during inclement weather. I would recommend some additional warm clothing and/or blankets and some water and snacks. A set of jumper cables and a small tool kit are also a good idea.

Secondly, if you will be going out of town please consider utilizing the police department's House Watch Program. This is a service that we are happy to provide at no charge to our residents. If you sign up for a house watch while you are away, Officers will drive by and check your property several times each day. We will also walk around your property once each day and check every door and every window as well as any vehicles that are present. We will also provide you a record of these checks once you return home. The form to sign up for a House Watch can be found online at <http://www.hurstbourneacres.org/police/policeforms.html> or we would be happy to bring the form to you, just give us a call at (502) 499-2352 or (502) 553-7318. It is important that we have all of the information on the form in order to provide you the best service possible.

Information that is really important includes:

- Emergency contact info (your home phone number does no good if you're not there)
- Alarm Company info if applicable
- Anyone that will have authorized access to your property while you are gone

If you sign up for a house watch, please also remember to notify us if your plans change such as if you will be leaving or returning home at an earlier or later date.

The regular meeting of the City Commission was called to order at 6:30 PM on October 13, 2016 at the meeting room of the Hurstbourne Acres City Hall/Police Department, 1916 Hurstbourne Circle, Louisville, Kentucky, with the following persons present;

September 8, 2016 Minutes

Commissioner Nichols made a motion to accept the minutes as published. The motion was seconded by Commissioner McAllister and carried unopposed.

Treasurer's Report

Sharon Hollkamp read the monthly treasurer's report for September, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner McAllister made a motion to accept as reported. Commissioner Eskridge seconded the motion which then carried unanimously.

Warrants

Sharon Hollkamp read the warrants for September, 2016 and copies were made available for all people in attendance. After a discussion, Commissioner Nichols made a motion to accept as reported. Commissioner Renninger seconded the motion which carried without opposition.

Attorney's Report

Derek McMahan from Steve Emery's office introduced himself. Before his report Mayor Fore wanted to convey to our attorney the City's displeasure for failure to provide the information requested by Commissioner McAllister regarding the sidewalk project on Blowing Tree. Attorney McMahan then stated that a demand letter was sent to the owners of the Meadows Apartments. However, he did not have a copy available for review by Mayor Fore & Commissioner McAllister. In accordance with a request by Mayor Fore, a copy of the letter will be forwarded to Commissioner McAllister and himself as soon as possible.

Police Chief Griffin reported the following for September;

September Highlights;

- All officers completed KLC recommended monthly training,
- 4 offense reports were for theft from a vehicle on Haviland Avenue, theft from a vehicle on Hurstbourne Lane, loss of a passport on Taylorsville Road, and sexual abuse at the Meadows Apartments,
- The Department supported the city picnic,
- All Golden Watch residents checked weekly,
- All businesses in the shopping centers checked daily,
- Explorer is in good working order, and the new Ford Taurus has had equipment installed. It is also waiting for the decals for striping,
- Both Officer Holston and Sergeant Flowers received commendations,
- Police Chief Griffin contacted the property manager for the vacant home located at 4713 Taylorsville Road discussed at last month's meeting. He now has the contact information for the bank that owns the property so that a citation can be issued.

In a question from Commissioner Nichols, Chief Griffin advised that warnings have been issued to speeders in our City with the next step being citations.

COMMITTEE REPORTS

Parks

Commissioner Eskridge provided the quarterly report for the Park. The only issues he found after a physical and visual inspection were some loose bolts on the playground equipment and the need to rake and smooth out the sand. In other news, one of the pine trees recently planted in the park is showing signs of distress, and may need to be replaced. Concerning the intrusive vines affecting at least 2 pine trees on the Bunsen Parkway berm, a horticulturist that Commissioner Eskridge recently met, inspected the trees. He recommended cutting the vines away near the base of the trees, and wait to see if they survive. At this point, he stated, the vines are otherwise grafted to the trees, and cannot be removed without killing them. The Port-A-Let will remain in the Park until after Halloween. Quotes for the cost of maintenance of the picnic tables and gazebo are being obtained, and a report will be furnished at next month's meeting. He also proposed some kind of Christmas program in the Park this year, including pictures with Santa. Finally, after a suggestion by Sharon Hollkamp to have tennis courts installed in the Park, and getting a favorable response from the Commission, Commissioner Eskridge said that he would do the necessary research to get an idea of the feasibility and cost.

Sanitation

Commissioner McAllister reported that a couple of residents had damaged waste cans which have since been replaced. Also, there was a missed yard waste pickup which was remedied. In a question from Mayor Fore, Commissioner McAllister provided an update regarding the refurbishing of the city entrance signs (approximately another 10 days to complete and rehang). He suggested that the wrought iron be repainted before the signs are rehung, and was given approval. He has no further information yet on the cost and maintenance of having surveillance cameras installed in the City. Finally, as mentioned earlier, he is still waiting for information from our attorney regarding the sidewalk project on Blowing Tree.

Roads

Commissioner Nichols advised that she has ordered a new sign to be installed at the curve on Hurstbourne Lane. A couple of vendors have been contacted about new shrubs for the city entrance signs, and will contact 2 more before making a decision. Concerning the repainting of the light poles, she has not heard any further from LG&E. Finally, the new street signs on Woodfield have been installed. They now correctly reflect 'Road' and not 'Avenue'.

Police

Commissioner Renninger reported that she had spoken with Dana Spratt from the Louisville Metro Emergency Services Department about surveillance cameras and will forward to Commissioner McAllister all of the information she developed along with her phone number. She mentioned that the Impala has been sent to be auctioned, and thanked Commissioner McAllister for his help in finding the auction location and shipping off the car. Lastly, she praised Sergeant Flowers for his Identity Theft presentation at Nunnlea.

OLD/NEW BUSINESS

Nuisance Ordinance House Update

Mayor Fore provided an update to the house on Hurstbourne Lane which was cited for violations of the City's nuisance ordinance. Several of the violations have been addressed, and the property should be vacated within 60 days and put on the market. It was suggested that the City consider purchasing the house, if cost effective, to be converted for use as a 'City Hall'.

Garage Permit Application

Mayor Fore has received a garage permit application for the property at 1800 Addington Avenue which he has reviewed. He believes it is in compliance with the ordinance and requested that the permit be issued. After a discussion, it was agreed that a special meeting be held so that all of the commissioners can review the application before formally approving a permit.

1st Reading of Vacant Property Ordinance

Mayor Fore completed the first reading of Ordinance #5, Series 2016, an ordinance requiring registration of certain, vacant residential properties.

Commissioners Forum

Mayor Fore reminded everyone of the forum to be held on Sunday, October 16, at 1:30 pm at the Hurstbourne Acres City Hall. The candidates for city commissioner will be given time to outline their qualifications and answer questions. Doug Rogers, Chairman of the Ethics Committee, will be the moderator.

There being no further business or discussion, the meeting was adjourned.
