We have been receiving some complaints in reference to speeding in the neighborhood and particularly on Woodfield Road. Please be aware that we are will be increasing enforcement of traffic violations in the neighborhood. Our goal is to increase awareness of traffic safety issues in the area and not to cost our residents any of their hard earned money. With that being said, our main focus must always be on the safety of all of our residents and if writing traffic citations becomes the best solution to the problem, then that is what we will do. Just for reference, a citation for speeding 10 mph over the limit or coasting through a stop sign will cost the driver over \$150.00 in fines and court costs. Please be aware that the speed limit on all

streets within Hurstbourne Acres is 25 mph and that the stop signs in the neighborhood are there for the safety of all. Please drive safely, observe the speed limits, and come to a complete stop at all stop signs for the safety and benefit of all of our residents. **If you see something, say something!**

There is a definite increase in delivery trucks using our streets, which I feel certain some have emission leaks.

The regular meeting of the City Commission was called to order at 6:30 PM on June 8, 2023 at the meeting room of the Hurstbourne Acres City Hall/Police Department, 1916 Hurstbourne Circle, Louisville, Kentucky, with the following persons present;

May 11 Minutes

Commissioner Renninger made a motion to accept the minutes as published. The motion was seconded by Commissioner Theiss and carried unopposed.

Treasurer's Report John Bloomer read the Treasurer's Report for May. Commissioner Renninger made a motion to accept. The motion was seconded by Commissioner Theiss which carried unanimously.

Warrants

John Bloomer read the Warrants for May. Commissioner Eskridge made a motion to approve. The motion was seconded by Commissioner Theiss and carried unanimously.

**Police Report** Police Chief Griffin reported the following for May; -Offense reports-4, -Accident reports-2, -Arrests-2, -Traffic stops-11, -Citations issued-8, -Warnings issued-3, -Contacts with other agencies-0, -House watches-7, -Courtesy notices-2, -Directed patrols-0, -Calls for service-65, -License plates confiscated-0, -Motorists assists-3, -Funeral watches-0, -May Highlights -All officers completed KLC recommended monthly training, -The four offense reports were for a criminal mischief in the Meadows Apartments, a criminal mischief in the Taylorhurst Shopping Center, a theft of a vehicle in the East Chase Apartments, and an assault in the East Chase Apartments, -Department completed a CJIS audit by Kentucky State Police, -Department supported the city yard sale, -All Golden Watch residents checked on weekly, -All businesses in shopping centers checked on daily, -All vehicles are in good working order. Attorney's Report Attorney Cato will be attending the upcoming Kentucky League of Cities Summer Conference. He said he would update the Commission with any pertinent information afterwards. Other issues will be discussed later in the meeting. **Public Comments** The following were comments that were made: -A resident advised that the recent large item pickup did not go as planned suggesting that clarification is needed for how it is to work. Commissioner

Eskridge and Mayor McAllister will get additional information,

-Some trees in the Park need to be staked up,

-Mayor McAllister and Attorney Cato will check ordinances regarding whether

Airbnbs are acceptable in the City,

-A resident had a complaint about a dog barking at all hours of the day and asked

whether anything could be done. Mayor McAllister said that there is a noise

ordinance and asked the Police Department to visit the owner of the dog to

resolve,

-There was a question about whether parking trailers in a driveway was against

ordinance. Mayor McAllister and Police Chief Griffin clarified, -Resident on Cardwell Way brought to the attention of the Commission a drainage

problem with the the homes next to the school. Mayor McAllister said that he

would start working on a solution.

## COMMITTEE REPORTS

## Park

Commissioner Theiss advised that one of the swings in the playground area is in the

process of being repaired. After approval by the Commission, new mulch will be purchased and

laid for a price of \$2681. Tree work in the Park will continue soon once our vendor has caught

up on other jobs. Commissioner Theiss stated that portions of the berm by the Park is not being

maintained by the owners. He suggested that the City do the work and then bill the owners of

the berm. Mayor McAllister said that he will send a letter to the property owners first to give

them notice before any further action is taken.

## Sanitation

Commissioner Eskridge was asked by his wife Kay to find out when the Commission

wants the newsletter to be sent. Following a discussion, it was decided that the goal is to have

the newsletter available by the first of the following month. Lastly, the Spring Junk pickup is

scheduled for this Saturday (1 large item and several smaller items).

## Streets

Commission Nichols confirmed that the light at the end of Bristol is now fixed. The only

other item discussed was the sealing of city streets advising that the sealing product last between one and two years.

## Police

Commissioner Renninger advised that she talked with the Nunnlea Beautification League about the crumbling steps to the Police Department. The process to get the steps repaired/replaced is underway. Finally, All ABC renewal letters have been sent.

Old/New Business

Fence Permit

The Commission reviewed the Fence Permit Application for the property at 1811 Wesley Avenue which was subsequently approved. The Clerk was directed to notify the owner

and issue the permit.

#### Sanitation Bid

With the issues that the City has recently had with our sanitation vendor, Commissioner Eskridge and Mayor McAllister will meet. They will discuss the bid process and specifics about what the City wants to include in a contract that would address some of the problems.

## Annexation

Hurstbourne Acres is once again seeking to annex Arboro Place and Hallsdale Drive. Mayor McAllister will contact the residents there and then meet with Attorney Cato to determine the next steps.

## Sidewalk Project

Attorney Cato is still waiting to hear back from the attorney for the prior owners of the Meadows Apartments as he is the best contact we have to get the sidewalk project moving forward.

## PuppyGram

Attorney Cato sent a letter to the Attorney for the owner of PuppyGram on April 13,

2023 who then requested a copy of all correspondence from and to our Commission regarding

PuppyGram. The correspondence was reviewed by their attorney and is willing to meet with

Attorney Cato and Mayor McAllister for further discussion.

There being no further business or discussion, the meeting was adjourned.
