Louisville Metro council recently passed an ordinance banning the retail selling of pets. This ban will take affect October 1, 2024. I did speak With Metro Council members Kevin Kramer and Marilyn Parker regarding this issue. Councilman Kramer was opposed to the ban and Councilwoman Parker was in favor, and asked me to speak at the council meeting. I did not attend as I did not want to jeopardize the city's legal standings if we were to go to court. It is my understanding as well as attorney Alan O'Bryant that Puppygram pet store and Hagan properties is clearly in violation of the declaration of restrictions agreed to by the property owners, and the City of Hurstbourne Acres in July of 1986. The City of Hurstbourne Acres will likely file a law suit against the Puppygram and Hagan properties before this situation can get resolved. We have 63 restrictions on that property. It is our duty to enforce those restrictions.

House Watch Program: The House Watch Program is available to all residents that own or rent a house in the city. If you will be out of town or if your house will be vacant for a period of time for some reason, please consider requesting a House Watch. If you request a House Watch, an officer will check your property at least once during each shift. All accessible doors will be physically checked and all accessible windows will be checked visually. You will need to fill out a House Watch Form that will provide needed information for us to serve you effectively. We would be happy to drop a copy of the House Watch

Golden Watch Program: The Golden Watch Program is available to all of our older residents that would like to have an officer check on them. This is a voluntary program for those that would like to sign up. Once a week an officer will stop by or call, depending on the choice of the resident, to talk for a little while and see if there is anything that they might need assistance with. Attorney's Report

Attorney Cato said that legal issues and his recommendations for the City would be

discussed later in executive session at the end of the meeting.

Public Comments

The following comment was made:

-A large limb from a tree damaged by the recent storm is overhanging Blowing

Tree Road presenting a risk to vehicles and pedestrians.

Attorney Cato has been

asked to send a formal letter to the owner of the property to get the issue resolved.

COMMITTEE REPORTS

Park

Commissioner Theiss outlined some of the costs to clean up after the storm on August 25.

Mayor McAllister advised that the payment for those expenses should be charged to the General

Fund. In other news, the annual city picnic coming up on September 24 is on schedule.

However, Commissioner Theiss advised that the number of door prizes may be down from

previous years. There are still plans on having the bike safety course with a suggestion to locate

it at the end of Bristol Avenue. Residents living there will be contacted first for their approval.

He is working on getting estimates to clean up behind the berm next to the office buildings.

Sanitation

Commissioner Eskridge is still planning on having the community cleanup day on

September 23, the day before the picnic. Volunteers are needed. Junk pickup day is scheduled

for this Saturday, September 16. More information will go out on Reach Alert. Regarding the

disposal of electronic equipment, such as TVs, Louisville Metro has a location each month where

residents can take their unwanted items. Commissioner

Eskridge said that on November 18 he

would take all items his truck can hold over to the closest location, the Shelbyville Campus.

Otherwise, residents are encouraged to drop them off themselves. Lastly, he has spoken to Greg

at Eco-Tech about the tree giveaway this year. Eco-Tech is going with a different company this

year and the number available for the City will be between five and eight.

Streets

Commission Nichols advised that she is working with a company to get the city streets

striped again. She also mentioned that the main entrance to our city from Taylorsville Road is

overwhelmed with signage and looks terrible. The Commission will review and take any

necessary action. Mayor McAllister also asked Commissioner Nichols to see about moving the

speed hump signs to the new appropriate location.

Police

Commissioner Renninger provided the following report to be read in her absence:

A resident suggested that in order to make the Park more accessible, a

walkway from the parking area to the gazebo would be helpful. A thank you was

received from several residents regarding the cleanup of Blowing Tree Road,

including from the storm damage. Amlung did a great job clearing the roadway and

picking up storm damage.

Old/New Business

Sidewalk Project and PuppyGram

Attorney Cato stated that these two ongoing issues will be discussed in executive session.

Executive Session

There being no further business or discussion, Commissioner Theiss made a motion to recess the meeting to go into an executive session to discuss the Sidewalk Project and PuppyGram situations. The motion was seconded by Commissioner Eskridge and carried without opposition. Once the executive session is complete, the regular meeting will be rejoined and then adjourned.
