City of Hurstbourne Acres, Kentucky Ordinance No 3 Series 2022

Whereas the City Commission of the City of Hurstbourne Acres, Kentucky has the authority Pursuant to statute to enact Ordinances relating to the city, and

Whereas the City Commission deems it necessary to establish the compensation of City officials and the classification and compensation of City employees;

BE IT ORDAINED BY THE CITY OF HURSTBOURNE ACRES, KENTUCKY THAT:

Section 1. COMPENSATION OF ELECTED OFFICIALS:

The Mayor and City Commissioners are compensated as follows:

Mayor - \$7,560.00 with an annual cost of living adjustment beginning July 1, of each year based on the (SSA) per annum

City Commissioners - \$4,200.00 with an annual cost of living adjustment beginning July 1, of each year based on the (SSA) per annum

Section 2. CLASSIFICATION AND COMPENSATION OF CITY EMPLOYEES

The following is a list of City employee classifications and compensation for each classification:

- City Clerk: Direct operations of the City Clerk's office; Clerk of governing body and custodian of records; performs other duties as assigned by the Mayor and Commission. Annual Compensation - \$4,800.00
- 2. City Treasurer: Responsible for the financial accounts of the City; manages budget and cash flows issues; performs other duties as assigned by Mayor and Commission.

 Annual Compensation \$7,500.00
- 3. Chief of Police: Directs all functions and operations of the Police Department in an efficient and effective manner to ensure its objectives of preservation of the peace and protection of life and property; performs administrative and managerial police work of considerable difficulty at the upper managerial level; promotes the interest of the Department as a liaison to the Mayor and the Commission and through contact with community organizations.

Annual Compensation - \$36.00 per hour, approximately 1,000 hours/year.

4. Police Officer(s): Assists the Chief of Police in all phases of the administration of the Police Department; applies Department policy, procedures, goals, and objectives; promotes the interest of the Department through contact with community organizations and citizens; performs other related duties as required.
Annual Compensation – 1 position (Lieutenant) \$28.00 per hour, 1 position (Sergeant) \$26.00 per hour, 5 positions at \$24.00 per hour,

Section 3. This Ordinance is effective immediately and shall be published as is required by law.
