NOW THEREFORE, BE IT ORDAINED BY THE CITY OF HURSTBOURNE ACRES, KENTUCKY:


Section 1: That the annual budget for the fiscal year beginning July 1, 2001 & ending June 30, 2002 is hereby adopted:


