**AN ORDINANCE AMENDING ORDINANCES,  
READOPTING ORDINANCES, AND  
REPEALING ORDINANCES**

The City Commission of the City of Hurstbourne Acres, Kentucky, in compliance with Kentucky Revised Statute (KRS) 83A.060, determined that it is necessary to amend, readopt, or repeal certain ordinances now existing.

The City amended certain Ordinances, to add an enacting clause to each.

The City readopted certain Ordinances as regular, non-emergency, ordinances.

The City repealed certain obsolete or unconstitutional Ordinances.

The City amended an ordinance to correct a spelling error.

The City amended an ordinance regulating and controlling vehicular traffic on the streets of the city, and in accordance with KRS 83A.060(9), does hereby publish the full text of that section.

**SECTION 4.** The City of Hurstbourne Acres, Kentucky, does hereby amend Ordinance 450.00

(Ordinance No. 6, Series 1964), as follows:

**AN ORDINANCE REGULATING AND CONTROLLING  
VEHICULAR TRAFFIC ON THE STREETS IN THE  
CITY OF HURSTBOURNE ACRES, KENTUCKY**

WHEREAS, the public safety is protected by the adoption and enforcement of traffic and vehicular control ordinances,

~~THE BOARD OF TRUSTEES OF THE CITY OF HURSTBOURNE ACRES DOES~~

ORDAIN AS FOLLOWS: Be it ordained by the City of Hurstbourne Acres that the following regulations shall govern traffic and vehicular control within the City:

1. RECKLESS DRIVING. No vehicle shall be operated, propelled or driven in a reckless manner, or at a speed, or in a manner so as to endanger the life, limb, or property of any person.

Any person who drives any vehicle in such a manner as to indicate either a willful or wanton disregard for the safety of persons or property is guilty of reckless driving.

Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Thirty Dollars (\$30.00) nor more than ~~One Hundred Dollars (\$100.00)~~ One Hundred Ten Dollars (\$110.00) for each offense., OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

2. TRUCKS AND SLOW MOVING VEHICLES. Slow-moving motor vehicles and all vehicles used or designed to be used for the pulling or hauling of freight must be operated or driven in single file as close to the right-hand side of roadway as traffic conditions permit.

Any person, firm or corporation violating any provision of this section shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense., OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

3. OBSTRUCTING TRAFFIC. It shall be unlawful for the operator of any vehicle to so operate or permit same to remain standing in any street in such a manner as to become an obstruction to traffic thereon.

Any person, firm or corporation violating any provision of this section shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense ~~;~~ OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

4. SPEED LIMIT. No operator of a vehicle upon any street of the City of Hurstbourne Acres shall drive at a greater speed than is reasonable or prudent, having regard for the traffic, the use of the highways, and the prevailing conditions; providing, that the maximum rate of speed at any time shall be twenty-five (25) miles per hour.

Any person, firm or corporation violating any provision of this section shall be fined as follows:

For speeds between 25 and 30 mph. - ~~\$10.00~~ \$27.50 OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

For speeds ~~between~~ exceeding 30 mph. ~~and up to~~ 40 mph. - ~~\$15.00~~ \$37.50 OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

For speeds in excess of 40 mph. - ~~15.00, plus \$2.00 for each mile of speed in excess of 40 mph.~~ \$44.50, plus \$2.00 per mile per hour in excess of 40 miles per hour OR a fine that is equal to the fine provided by Kentucky Statute for the same offense.

whichever is greater.

5. STOP SIGNS. The operator of any vehicle traveling along any street intersecting another street, subject to control by a properly authorized stop sign, shall bring such vehicle to a complete stop and shall make no attempt to drive upon, into or across such streets, protected by a stop sign, unless such vehicle can be driven without danger of collision with any other vehicles.

Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Twenty Dollars (\$20.00) nor more than One Hundred Dollars (\$100.00) for each offense ; OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

6. GLARING LIGHTS. It shall be unlawful for the operator of any vehicle, driving the hours when lights are required, to operate such vehicle with the rays of its headlights projecting ahead on the high-beam when other vehicles are approaching from the opposite direction within Five Hundred (500) feet.

Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Twenty Dollars (\$20.00) nor more than One Hundred Dollars (\$100.00) for each offense ; OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

7. REQUIRED LIGHTS. All two wheel motor vehicles and bicycles shall display in front at least one headlight, and all other motor vehicles at least two headlights. All motor vehicles shall display in the rear at least one red taillight, and bicycles shall have

adequate and effective red reflector.

Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Twenty Dollars (\$20.00) nor more than One Hundred Dollars (\$100.00) for each offense ~~;~~ OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater; except, the violation of this section may be excused if the vehicle has the proper physical equipment but has suffered a light failure, which has been corrected and the receipt for the repair is exhibited.

8. ANTI-NOISE OR NUISANCE ORDINANCE. It shall be unlawful to operate any motor vehicle on any street, unless such motor vehicle is equipped with a sufficient and suitable muffler in good working condition, or when such muffler is cut-out or removed. No cut-out shall be so arranged or connected as to permit the operation or control thereof by the operator of any motor vehicle while operating such vehicle.

It shall be unlawful to sound any horn, siren, or similar instrument, except by proper public and emergency authorities, unnecessarily or in such a manner as to constitute a nuisance thereby.

Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Twenty Dollars (\$20.00) nor more than One Hundred Dollars (\$100.00) for each offense ~~;~~ OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.

9. IMPROPER LICENSE PLATES. It shall be unlawful to operate any motor

vehicle on any street with any license plate that is expired, was issued for another vehicle, or is improperly used in any manner.


Any person, firm or corporation violating any provision of this section shall be fined not less than ~~Five Dollars (\$5.00)~~ Ten Dollars (\$10.00) nor more than One Hundred Dollars (\$100.00) for each offense ; OR a fine that is equal to the fine provided by Kentucky Statute for the same offense, whichever is greater.
