## CITY OF HURSTBOURNE ACRES, KENTUCKY ORDINANCE ESTABLISHING DUTIES AND A PAY SCALE FOR A POLICE OFFICER

Whereas, the City of HURSTBOURNE ACRES, has found it necessary to create the office of Police Officer, for the City of HURSTBOURNE ACRES,

Whereas, the City Commission deems that it is in the best interest of the citizens to create this position for the City of HURSTBOURNE ACRES,

THEREFORE, be it hereby enacted and ordained that:

SECTION 1: THERE IS HEREBY CREATED THE OFFICE OF:

[A] Police Officer

SECTION 2: THE POWERS AND DUTIES OF THE FOREGOING OFFICE IS
HEREBY ESTABLISHED AS FOLLOWS:

- [A] Police Officer: perform all duties of a law enforcement officer, within the City of Hurstbourne Acres, and shall have all of the powers of a law enforcement officer which are customary in the Commonwealth of Kentucky.
- SECTION 3: THE OATH OF OFFICE TO BE EXECUTED BY THE POLICE OFFICER

  SHALL BE THAT SET FORTH IN SECTION 228 OF THE CONSTITUTION

  OF THE COMMONWEALTH OF KENTUCKY.
- **SECTION 4**: COMPENSATION AND PROBATIONARY PERIOD FOR EACH OFFICER SHALL BE AS FOLLOWS:
  - [A] Police Officer: \$20.00 per HOUR.
