CITY OF HURSTBOURNE ACRES, KENTUCKY  
ORDINANCE  
ESTABLISHING A NEW PAY SCALE FOR NON-ELECTED OFFICES

WHEREAS, the City of HURSTBOURNE ACRES, has created the office of Police Chief and Police Sergeant, for the City of HURSTBOURNE ACRES,

WHEREAS, the City Commission deems that it is in the best interest of the citizens to modify the pay given to the individuals appointed to those positions,

WHEREAS, the City is required to compensate that Police Chief and the Police Sergeant,

BE IT HEREBY ORDAINED AND ENACTED BY THE CITY OF HURSTBOURNE ACRES THAT:

SECTION 1: EFFECTIVE JULY 1, 2010, COMPENSATION FOR THE OFFICE OF POLICE CHIEF SHALL BE AS FOLLOWS:

[A] Police Chief: \$ 4,166.67 per month, plus KLEPG funds of \$ 3,099.96 per year, and \$ 2,500.00 in Health Insurance credit per year, plus life insurance (in an amount to be determined by the City Commissioners) and a reasonable uniform allowance.

SECTION 2: The Police Chief serves as an "at will" employee of the City.

The Police Chief shall patrol, or otherwise provide service, to the City.

The Police Chief shall give the Mayor at least 30 days prior notice of his intent to leave office, if the Police Chief decides to terminate his employment with the City. If the Police Chief fails to give at least 30 days prior notice of his intent to leave office before the Police Chief decides to terminate his employment with the City, the City may inform prospective employers that the Police Chief failed to give timely prior notice of his intent to leave office.

The Police Chief may engage in lawful outside employment, in accordance with Kentucky law; however, if the Police Chief does engage in lawful outside employment, the Police Chief shall provide notice, in writing, the name of the outside employer with the City Clerk and shall provide a copy of that notice to the Mayor, before the Police Chief engages in lawful outside employment.

SECTION 3: EFFECTIVE JULY 1, 2010, COMPENSATION FOR THE OFFICE OF POLICE SERGEANT SHALL BE AS FOLLOWS:

[A] Police Sergeant: \$ 3,333.34 per month, plus KLEPG funds of \$ 3,099.96 per year, plus life insurance (in an amount to be determined by the City Commissioners) and a reasonable uniform allowance.

SECTION 4: The Police Sergeant serves as an "at will" employee of the City.

The Police Sergeant shall patrol, or otherwise provide service, to the City.

SECTION 3: This Ordinance is effective immediately and shall be published as is required by law.
