An Ordinance adopting the City of Hurstbourne Acres, Kentucky Annual Budget for the fiscal year July 1, 2013 through June 30, 2014 estimating revenues and resources and appropriating funds for the operation of the City Government

Section 1: That the annual budget for the fiscal year beginning July 1, 2013 and ending June 30, 2014 is hereby adopted:


