#### Attorney's Report

Attorney Baker advised that the hearing for the sidewalk project has once again been rescheduled. The new date is June 4 at 9:30 am. The second reading of Ordinance #3, Series 2020 amending Budget Ordinance #5, Series 2019 was completed by Attorney Baker. Commissioner Renninger made a motion to enact and ordain and was seconded by Commissioner Nichols. The motion carried unanimously. Attorney Baker then completed the first reading of Ordinance #4, Series 2020 establishing the investment policy for the City.

#### **Treasurer's Report**

Amy Underwood answered questions regarding the treasurer's report for March, 2020. Since not all of the commissioners had a chance to review the report, the motion to accept or reject has been postponed until the meeting of the Commission in May.

#### Warrants

Amy Underwood answered questions regarding the warrants for March, 2020. Since not all of the commissioners had a chance to review, the motion to accept or reject has been postponed until the meeting of the Commission in May.

#### **COMMITTEE REPORTS**

#### **Parks**

Commissioner Eskridge provided an update about the community garden. Two members of the steering committee will no longer be able to participate. Also because of the timing to begin the planting, the community garden and grant requests have been placed on hold.

Due to the COVID-19 situation, the traditional Easter Egg Hunt has been canceled. In its place will be 'Bunny Hop Around The Block'. In the upcoming newsletter, a blank Easter egg will be included. Residents wishing to participate should

color the egg and attach it to their front door by 10:00 am on April 11. They will also place on their porch a basket of plastic eggs filled with candy. Children will then know at which houses to find the eggs.

Lastly, Commissioner Eskridge brought up for discussion, the 2 bids received for the grass cutting contract. After a review by the Commission, Bid #2 was unanimously accepted. Bidder #2 will be contacted and all the appropriate legal paperwork signed. Commissioner Renninger suggested that a special write up about Butch of Stump Busters be included in the newsletter. It would express the City's appreciation for the many years of excellent service he provided. A formal Certificate of Appreciation would be presented to him at the City picnic.

#### **Sanitation**

Commissioner Bohnenkamp explained the changes by Ecotech as a result of the COVID-19 virus. They are outlined on the home page of the Hurstbourne Acres website.

In other news, there was a complaint about a resident burning debris in his backyard, twice (there is a county ordinance restricting the burning of trash/debris on residential property). Therefore, if it happens again, our police department should be contacted, and the person will be cited.

Finally, a resident reported that their recycling was missed, which has since been resolved.

#### **Police**

Commissioner Renninger scanned our last city audit and it has been added to our City's website. Also, she advised that she watched the March 26 webinar about the Hurstbourne Parkway Improvement Study. Part of the plan is to widen Hurstbourne Parkway by 25 feet. There is to be another meeting this summer and she is encouraging residents, particularly on Hurstbourne Circle and Blowing Tree, to attend.

#### **Streets**

Concerning the 'No Parking This Side' markings for Hurstbourne Circle, Commissioner Nichols was unsure where the markings are to begin and end. Mayor McAllister said he would re-stake and let her know.

#### **Old/New Business Miscellaneous**

After Mayor McAllister and Commissioner Eskridge began the installation of the wheel stops by the Park, they determined that the job was bigger than they anticipated. Resident Billy Noel offered his service, and he completed the installation. The agreed price to install the wheel stops was \$200.

Lastly, Commissioner Eskridge is working on ways to assist the businesses at Taylorhurst by encouraging residents to support their local businesses.

There being no further business or discussion, the meeting was adjourned.

#### **COVID-19 Pandemic Emergency Requirements**

The COVID-19 virus is the major topic of discussion in our offices and homes. You may be aware that our industry has been designated as an "essential services" industry. As such, we can continue to operate and collect your trash. We have determined there are additional steps we must now take to protect our employees. We are confident that the instructions from our Governor as well as instructions from experts throughout the country are critical to protecting each of us and flattening the curve.

Effective immediately, these are the steps we are taking to protect our drivers and tippers that collect your trash:

- 1) All trash must be properly bagged and contained inside a can. **No loose trash or bags on the ground will be collected.** Trash cans should have handles for safe collection. Clean recycling must be placed in the recycle container/bin. No loose cardboard or bags on the ground will be picked up.
- 2) We request no large or bulk items be placed at the curb at the present time. If you have an emergency pickup request, please contact our office at 502-935-1130. We plan to utilize special equipment that will not require any direct contact to collect a bulk item. There will be a special emergency charge if you must have bulk items collected. We strongly urge you to delay bulk item collection until further notice. This service must be scheduled. If anyone in your home has been in contact with a COVID-19 patient or if you have anyone in the home that has been sick please refrain from requesting an emergency bulk pickup.
- 3) No garage or basement cleanouts will be collected at this time.
- 4) The yard waste will be collected, but we will limit collection to 10 bags or less each week. Approved biodegradable bags will be accepted. All yard waste containers must be properly labeled.
- 5) We have been approved to mix materials in the same truck if circumstances warrant.
- 6) It is highly recommended that you wipe down the handles of your trash can to prevent any exposure.

This policy will be active and in place immediately until further notice.

Please remember that our employees are trying their very best to serve you during this extremely dangerous and difficult time. Help us prevent our employees from contracting the COVID-19 virus. Our prayers are with you, our community, state, and our country!



#### CITY OF HURSTBOURNE ACRES ORDINANCE NO. 03, SERIES 2020

AN ORDINANCE AMENDING ORDINANCE 5, SERIES 2019 THAT ADOPTED AN ANNUAL BUDGET FOR FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020 FOR THE CITY OF HURSTBOURNE ACRES, KENTUCKY.

WHEREAS, the City of Hurstbourne Acres adopted an annual budget for Fiscal Year July 1, 2019 through June 30, 2020 on June 27, 2019, and;

WHEREAS, it has become necessary to amend said budget to reflect needed expenditures.

NOW THEREFORE BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HURSTBOURNE ACRES, KENTUCKY AS FOLLOWS:

SECTION ONE:	Section 1 of Ordinance 5, Series 2019 is amended as follows:

SECTION TWO: Any ordinance or part of ordinance in conflict with this ordinance or any part of this ordinance is hereby repealed.

SECTION THREE: Should any section, clause, line, paragraph, or part of this ordinance be held unconstitutional or invalid for any reason, the same shall not affect the validity of the remainder of this ordinance.

SECTION FOUR: This Ordinance shall take effect upon publication.
