Yard Waste Reminder

Recently, a concern was raised about yard waste being deposited on non-Hurstbourne Acres property adjacent to our neighborhood. Our liberal waste removal program should prevent this happening by any of our citizens; however, here is the policy for your reference:

"Yard Waste" shall mean...those materials suitable for composting, and shall specifically include grass clippings, leaves, flowers and vegetable plants, brush, branches, limbs, and shrubbery trimmings. Limbs over six inches in diameter are NOT included. Christmas trees are to be collected, but shall not contain any decorations or stands.

Collection of Yard Waste as defined above, shall be contained in 32 gal cans or less, or an Ecotech toter, or certified compostable bags meeting ASTM D6400 standards by regulation. Ecotech will not be able to pick up yard waste that does not meet the specifications listed above and herein under normal scheduled pick up. Bundled yard waste materials cannot exceed four (4) feet in length nor 50 pounds in weight. If you have an unusual situation when you are unable to meet the waste pickup specifications listed above, you may contact Ecotech (502) 935-1130 with a request for pick up and an estimate of the additional charges (if any) that will apply to you.

Our Yard Waste pickup day is always Monday except on a holiday when it will be adjusted accordingly.

June Highlights

- Department continues to utilize revised operating procedures during the COVID-19 situation.
- All officers completed Kentucky League of Cities recommended monthly training.
- The 5 offense reports were for criminal possession of a forged instrument at Speedway, shoplifting at Vision First, shoplifting at Shoe Carnival, shoplifting at Liquor Barn, and a criminal mischief at Huntington Shopping Center,
- -ABC licenses were renewed for businesses selling alcoholic beverages.
- Licenses were not renewed for two businesses and one license is still outstanding.

- All Golden Watch residents checked on weekly.
- All businesses in shopping centers checked on daily.
- Explorer and Taurus are in good working order.

Attorney's Report

Attorney Baker advised that the hearing date for the sidewalk project is still scheduled for August.

Regarding the business on Taylorsville Road (Group Home), Attorney Baker is still in the process of pursuing additional information.

COMMITTEE REPORT

Parks

Commissioner Eskridge reported that he is still unable to confirm a definite date for the city-wide yard sale, the city picnic, or the reopening of the playground/pavilion. Louisville Metro requirements will continue to be monitored. Once Commissioner Eskridge has a plan in place, it will be discussed with Mayor McAllister before proceeding.

Sanitation

Commissioner Bohnenkamp had a request from a resident about disposing of a mattress and box springs. Ecotech should be contacted first before setting out large items. There was no other news.

Streets

Commissioner Nichols once again brought up the condition of the section of property by the car wash at Taylorsville Road and Hurstbourne Lane. It was determined that the highway department, not MSD, needs to address the issue.

Also discussed was the fireworks in the City around July 4.

Police

Commissioner Renninger reported that there were 6 businesses that renewed their ABC licenses.

Old/New Business

School at Pier One Location - Mayor McAllister advised that the owner of the property at the old Pier One store was considering, among other things, leasing it out as a school. The school, as imagined, would have an outdoor learning center. More information is required. Mayor McAllister did confirm that if a restaurant was being considered, it could not have a drive-through.

There being no further business or discussion, the meeting was adjourned.
