Here is what we need to do:

- On one of your trips to the grocery, buy three or four dozen plastic eggs and fill them with individually wrapped candy.
- 2. Hang the Easter egg picture attached to this newsletter in a window or door so children can see it from the street. Feel free to color the picture before hanging if you would like. This event is a combination of an Easter Egg Hunt and Trick-or-Treating. We hope it will be lots of fun for the children in our City as well as the adults. We can all enjoy hunting for eggs that have been hung in windows or doors. The more residents that participate, the more fun it will be for the children.

With that being said, we can be sure that winter weather will eventually be back. The news lately has been full of stories of bitter temperatures, ice storms, and power outages all over the country. Luckily, we were spared most of that but we did have some tree limbs come down, luckily causing no major damage, and one resident that had a furnace go out during the cold weather. All these situations can be devastating if you are not prepared.

It is always a good idea to keep some emergency supplies on hand in case unexpected situations arise. Most sources recommend maintaining a minimum of three days supplies for you and your family in case of an emergency. That is generally the time it takes for emergency services to ramp up during a major emergency. Make sure you keep up the service on your furnace and all other major systems in your house and keep an eye on the trees on your property. Commissioner Nichols made a motion to accept the minutes as published. The motion was seconded by Commissioner Renninger and carried unopposed.

## **Treasurer's Report**

The Commission reviewed the January Treasurer's Report. Commissioner Renninger made a motion to accept as furnished. The motion was seconded by Commissioner Nichols which carried unanimously.

## January Highlights

- Department continues to utilize revised operating procedures during the COVID-19 situation,
- All officers completed KLC recommended monthly training,
- All officers completed on-line training on de-escalation,
- The three offense reports were for a recovery of a stolen vehicle on
- Bunsen, a theft of a vehicle at Speedway and a shoplifting at Liquor Barn,
- All Golden Watch residents checked on weekly,
- All businesses in shopping centers checked on daily,
- Explorer and Taurus are in good working order.

## **Attorney's Report**

Attorney Baker confirmed that the 'hearing' regarding the proposed sidewalk along Blowing Tree Road is still scheduled for February 26, 2021 at 1:30 pm.

In other news, the owner of the property on Taylorsville Road has been notified of the complaint. The owner has until February 18 to reply.

The Commission completed the review of Resolution, Series 2021-1 which would request the General Assembly to review the allocation process for distribution of revenue to cities for infrastructure expenses, i.e. revenue-sharing programs funded by state motor fuel taxes. After Attorney Baker completed the reading of the Resolution, Commissioner Renninger made a motion to accept. The motion was seconded by Commissioner Bohnenkamp and carried without opposition.

Lastly, Attorney Baker answered questions for Commissioner Renninger about legal requirements for hiring full-time officers, primarily concerning benefits.

## **COMMITTEE REPORTS**

#### <u>Park</u>

In Commissioner Eskridge's absence, Mayor McAllister presented the report for the Park. At the meeting in March, Commissioner Eskridge will provide the estimated expenses and general conditions for reopening the playground. Regarding this year's Easter Egg Hunt, it will be like last year's, but more details will be furnished at the meeting next month.

Finally, he received no reply from either the Meadows Apartment manager or any legal representative about the fence along Blowing Tree Road. Our City continues to pursue an answer to the post/fence condition.

## **Sanitation**

Commissioner Bohnenkamp reported she had a complaint from a resident who said her recycle had not been picked up for 2 weeks. It was later learned that the resident did not know that the recycle pickup was now on Mondays. Lastly, there was an issue with two separate individuals walking their dogs. In one case, the owner did not clean up after their dog in a resident's yard. He claimed that he could not and headed to the new apartments off Bunsen Parkway. The other owner simply did not have his dog on a leash. After being advised that our City has a leash law, he complied with the request.

## <u>Roads</u>

Commissioner Nichols said the white striping on Hurstbourne Acres streets needs to be redone. Once the weather has improved and it is possible to complete, she will investigate the cost. In other news, since Hurstbourne Circle still does not have a posted sign concerning parking, Police Chief Griffin confirmed for Commissioner Nichols that the street markings are not enforceable. Finally, she recommended that the City investigate hiring more part-time police officers with the CARES Act money, but no decision was made.

## **Police**

Commissioner Renninger mentioned that there have been three incidents of snow removal so far this winter for which the City will receive invoices. A free library, located in the Park, was suggested by Commissioner Renninger.

Lastly, in order to be more cost effective when dealing with properties being rented in our City, Commissioner Renninger suggested a registry of some kind for owners of all rental properties. Mayor McAllister responded by saying the City would need to pass an ordinance which would include a requirement that all owners of rental properties provide their contact information to the City along with information on the renters. Attorney Baker advised that she already has a template for that type of ordinance. Mayor McAllister asked her to forward to him a copy for review.

There being no further business or discussion, the meeting was adjourned.
