Most of you have noticed the sealant put down from the park entrance on Haviland to the intersection of Haviland and Woodfield due to an emission spill by an Echo Tech truck. I, as well as the mayor, have been asked by several residents why we could not do this to all our streets as the look is impressive!

I met with Beargrass Striping on two different occasions and discussed options and cost. They could do one entire street at a time or half of a street. Doing half of a street would keep an open lane for thru traffic. NO CARS/VEHICLES WOULD BE ALLOWED TO PARK IN THIS LANE. It would take 24 hours for sealant to dry, after being put down on any area.

I made the mayor aware of the impact this would have on our residents, such as being unable to pull into or out of their driveways for 24 hours, thus having to find another place to park and some residents have difficulty walking. The Mayor and I discussed this and both of us feel that it would NOT be worth the inconvenience that it would cause our residents to contend with. That being our main concern.




Hurstbourne Acres Little Free Library was installed July 27, 2021.

#### June 10 Minutes

Commissioner Nichols made a motion to accept the minutes as published. The motion was seconded by Commissioner Renninger and carried unopposed.

#### **Police Report**

Police Chief Griffin reported the following for June, 2021:

#### June Highlights:

- All officers completed KLC recommended monthly training.
- The two offense reports were for a recovery of a stolen vehicle on Taylorsville Road and a theft from a vehicle in the Meadows Apartments.
- All officers completed 'use of force' training to include training/qualification with on duty and off duty handguns, training with tasers and review of 'use of force' policies and case law.
- All Golden Watch residents checked on weekly.
- All businesses in the Shopping Centers checked on daily.
- Explorer and Taurus are in good working order.

#### **New Financial Advisor**

Joel Shepherd was introduced as the new financial advisor for the City. He has taken over the accounts from Matt Anderson.

#### **Treasurer's Report and Warrants**

Treasurer Underwood was unable to attend the meeting due to illness. As a result, approval of the Treasurer's Report and Warrants for June have been postponed until next month's meeting.

#### Attorney's Report

The new hearing date for the sidewalk case has been scheduled for November 8, 2021, at 1:00 pm.

In other news, after no response from the Meadows Apartment owners regarding the condition of the fence, the Commission instructed Chief Griffin to issue a citation. Concerning the fence on the school side of Blowing Tree Road, it was suggested that Chief Griffin first talk with the principal.

#### **COMMITTEE REPORTS**

#### Park

Commissioner Eskridge discussed two items on the Playground/Park check list. A couple of the picnic tables needed some tightening of fasteners which he was able to handle. However, they still need further carpentry repairs for which he is seeking someone to complete. He said he would provide a resolution at next month's meeting. The other item that needs addressing is the removal of grass in the playground which he will handle this upcoming week.

The date for the City picnic is September 26th. A potential change to the food service would be boxed meals. Also, there may be a requirement that all unvaccinated guests wear masks. There are several new residents that may not be aware of the annual picnic. As a result, Commissioner Eskridge will place an open invitation to all residents through the newsletter. He will place signs around the City at the appropriate time as a reminder. In addition, he is working on donations from businesses.

Lastly, based on his feedback from the people who participated in the last yard sale, there will not be a second yard sale this year.

#### Sanitation

Commissioner Bohnenkamp advised that there had been a confusion about garbage/recycle pickup after the July 4<sup>th</sup> weekend. Since the holiday fell on the weekend, there was no change to the pickup schedule though many residents thought it would place pickups back one day. As a result, many residents placed their items out a day late. She contacted Eco-Tech who sent a truck out the next day to pick up primarily recycle. In the future, for all holidays, she will clarify pickup dates.

#### **Streets**

Commissioner Nichols advised the Commission that to seal Hurstbourne Acres city streets (2 coats), it would cost \$34,090. She was also quoted an extra \$6000 to apply a special seal to cracks and holes prior to the regular sealing. Although Bunsen Parkway does not require sealing, it does need striping at a cost of \$1797. To help reduce the inconvenience to residents during the sealing process, Commissioner Nichols asked to

meet with both Mayor McAllister and Chief Griffin for their suggestions before starting.

Finally, she advised that she still has not heard back from her contact at LG&E. She is seeking the cost to place an electrical outlet at the City entrance sign on Bunsen Parkway for lighting purposes. She will continue her efforts.

#### **Police**

Commissioner Renninger mentioned that of the potential ABC renewals, one business has left and one business, Chuck E. Cheese, has not renewed their license to serve alcohol.

Regarding rental properties in the City, she is currently managing the paperwork. She has a file where originals are kept, and electronic copies are sent to the clerk. There are nine rental properties in the City for which paperwork has been received.

Lastly, maintenance for the computers in the police vehicles is needed. She has found a vendor to provide that service.

#### **Old/New Business**

#### **Miscellaneous**

Mayor McAllister advised the City has still not received funds from the American Rescue Plan. He is in the process of checking to see why there is a delay.

Concerning the road fund money, each year paperwork has to be completed and sent to the Department for Local Governments. However, they have still not acknowledged receipt of this year's nine-page form causing a delay in receipt of the money.

Recently, there has been an issue with delivery services or individuals who enter Hurstbourne Lane from Taylorsville Road, drive past Woodfield Road to the house in question and then go back the same way they came in. From Woodfield Road toward Hurstbourne Parkway is one way. Police Chief Griffin suggested that a 'One Way' sign be placed before the curve and after the curve to better mark that stretch of road. Commissioner Nichols said she would handle.

Lastly, a resident at the meeting asked whether there was a City register of residents. It was suggested that it would make it easier for residents to meet other residents. However, others said that there might be a legal issue or

privacy issue, but Mayor McAllister said that he would check into it.

There being no further business or discussion, the meeting was adjourned.
