**Veterans Day is November 11.** Listed Below are a few deals for veterans. Be sure to check with your restaurant to see if they are honoring these deals.

### Veterans Day Restaurant Deals

To honor members of the military, these restaurants are offering Veterans Day deals on or around November 11.

Applebee's -- Veterans and active-duty military receive a free meal from a special menu on November 11. Dine-in only.

Aspen Creek Grill -- Veterans and active-duty military get a complimentary meal from a special menu from 11 a.m. to close on November 11.

Beef 'O' Brady's -- Veterans eat free on November 11 at participating locations with the purchase of equal or greater value up to \$10.

**September 9 Minutes**

Commissioner Nichols made a motion to accept the minutes as published. The motion was seconded by Commissioner Renninger and carried unopposed.

**Treasurer's Report/Warrants**

The City has recently hired a new Treasurer, John Bloomer. Due to the recent date of hire, there is no report or warrants to provide for this meeting.

Police Commissioner Renninger reported the following for September, 2021:

## September Highlights:

- All officers completed KLC recommended monthly training.
- The two offense reports were for a theft by deception on Hurstbourne Lane and a dog bite in the Meadows Apartments.
- New police officer, Steven Hile, was hired.
- Officer Hale completed his annual 40-hour DOCJT in-service training.
- Department supported the City picnic.
- All Golden Watch residents checked on weekly.
- All businesses in the Shopping Centers checked on daily.
- Explorer and Taurus are in good working order.

## Attorney's Report

Attorney Baker advised that the "Sidewalk" hearing is still scheduled for November 8, 2021 at 1:00 pm. In other news, she asked the Commission to review the documents provided regarding the potentially ineligible business being conducted at a residence in the City. This business was brought to the attention of the Commission a few months ago. The owner of the business, who has obtained a "home occupation" permit from Louisville Metro, was here to answer questions and offer his feedback. Following the discussion, the Commission tabled a decision until the next meeting in November.

Miscellaneous issues included the following:

- the need for the new treasurer to provide a financial statement concerning audit requirements for fiscal year ending in 2020
- Attorney Baker had no new information about the fence violation on Blowing Tree Road.
- Lastly, it was noted that KIPDA has a contact who can help with evaluating the use of the American Rescue Funds recently received by the City.

## Investment Update

Joel Shepherd, the City's Financial Advisor, outlined the status of the city investments. It was agreed that he needs to meet with our new treasurer so that he, the treasurer, has the most up to date information.

## COMMITTEE REPORTS

### Parks and Recreation

Commissioner Eskridge started his report with discussion of the Christmas Party this year. There were two major considerations - the 30% drop in attendance at the picnic from 2019, and the only date available of December 19, which it was thought, was too late for residents to include in their plans. As a result, the Commission decided to forego the party this year. However, the City will still sponsor the Holiday Lights Contest with a gift for the winner. Finally, the leaf pickup dates were announced: November 8, 9, 10, and 22, 23, 24, December 6, 7 and 8.

### Sanitation

Commissioner Bohnenkamp reported that it has been quiet regarding sanitation service (no recent complaints). She did note that a dumpster, requested in a previous meeting, is now located at the gate leading into the soccer fields. She also mentioned that the gate itself is currently down.

### Streets and Lights

Commissioner Nichols called the LG&E District Manager after the August meeting. She wanted to discuss an underground cable connection for getting lights installed at the sign as was discussed at the last meeting (there is an underground utility box with an access cover near the city entrance sign). She asked him for an estimate on this and knew it would take some time. After the September meeting, she then called twice leaving voicemail, but never heard back. As a result, she forwarded the name and phone number of the LG&E District Manager to the Mayor for his help.

Concerning the landscaping around the city entrance sign, the Commission in general has had difficulty in finding someone to do the work. Commissioner Renninger mentioned that there is a resident in the City who does that kind of work. Commissioner Eskridge said that he also knows the family and will provide Commissioner Nichols with their contact information.

Lastly, after installing the "One Way" sign on Hurstbourne Lane, a resident complained about its location. After a review with Police Chief Griffin and determining that the effectiveness of the sign would not be hindered by relocating it, Commissioner Nichols is having the sign moved.

## **Police**

Commissioner Renninger said that the Hurstbourne Acres City Hall was visited by a representative from KLC. She was inquiring as to why our Mayor and Treasurer were not bonded and haven't been for over a year. Attorney Baker was asked to research and determine the appropriate amounts for the bonds.

In other news, Commissioner Renninger reported that BoomBozz is now open for carry-out only, but they do have a patio outside for those that want to eat their carry-out there. The new Mexican restaurant has applied for a liquor license.

Finally, Speedway will be closed for several more weeks while the damage is repaired from the recent vehicle accident.

There being no further business or discussion, the meeting was adjourned.
