IRS Tax Scam

As the tax season approaches, so do the tax scammers. Here are a few things for you to remember:

- 1. The IRS does not initiate contact with taxpayers over the phone, or by email, text messages or social media.
- 2. Scammers use fake names and IRS badge numbers. They are generally common names and surnames to identify themselves.
- 3. Scammers spoof the IRS toll-free number on caller ID to make it appear that it is the IRS calling.
- 4. Victims hear background noise of other calls being conducted to make it seem real.
- 5. After threatening victims with jail time or driver's license revocation, scammers sometimes hang up and others call back pretending to be local police or DMV and the caller ID supports their claim.
- 6. Never give out your personal or credit card information to anyone over the phone.
- 7. If you get a phone call from someone claiming to be the IRS, here's what you can do. If you do not owe taxes or have never received a tax bill you can call the IRS at 1.800.829.1040 or call Treasury Inspector General for Tax Administration at 1.800.366.4484. The IRS will always contact you via the US Mail. The IRS encourages taxpayers to be vigilant against phone and email scams that use the IRS as a lure.

- All officers completed KLC recommended monthly training.
- The one offense report was for a domestic violence assault at the Taylorhurst Shopping Center.
- Lieutenant Kevin Mills retired from the department.
- All Golden Watch residents checked on weekly.

- All businesses in shopping centers checked on daily.
- Explorer is in good working order and the Taurus is currently in the body shop being repaired.

2021 Department Highlights Operations

- Department resumed normal operating procedures on June 1, 2021, following the COVID-19 situation.
- Department supported all City Sponsored Events (City Yard Sale, City Picnic, Trick or Treating, etc.).
- Alcohol Beverage Control Licenses were renewed for all businesses that serve and/or sell alcohol.
- Golden Watch Program continues and currently includes 5 residents.
- Personnel Lieutenant Mills and Officer
 Phelps resigned from the department.
- Officers Beahl, Hale and Hile were hired.

Training

- All officers completed their mandatory annual in-service training through the Department of Criminal Justice Training.
- All officers completed monthly Kentucky League of Cities recommended training.
- All officers completed Spring and Fall firearms Training to include day and night qualifications with duty handguns, off-duty handguns, and patrol rifles.
- All officers completed annual Use-of-Force training to include training on department policy, case law, de-escalation, and TASER deployment.

Equipment

- New computer systems were purchased for the department.
- New Durango PPV was purchased for the department.
- Annual inventory was conducted with all department equipment accounted for.

Attorney's Report

Attorney Baker's only item on the agenda was the sidewalk case. She advised that there is still no ruling on which to report.

COMMITTEE REPORTS

Parks and Recreation

Commissioner Eskridge commented on how well the Christmas decorations at homes in the City were received with the Renninger house getting the most votes. For next year, it was recommended there be something setup in the Park where people can vote for their favorite house decorations and enjoy a beverage (hot chocolate). There was a correction to the newsletter regarding the Reach Alert voting.

In other news, he provided details of the bid for tree trimming on Bunsen Parkway. There were two parts to the bid; for the required trimming, the amount was \$2980, and the second part was a maintenance component in the amount of \$6800. He did confirm that getting bids has been a problem.

Lastly, Commissioner Eskridge said that now is the time to consider getting City Ground Maintenance bids, i.e., grass cutting, landscaping, etc. After a discussion, the Commission agreed to retain the current vendor and not put out for bid.

Sanitation

Commissioner Bohnenkamp did not have anything new to report.

Streets and Lights

Commissioner Nichols expressed her appreciation for the house decorations this Christmas. She did suggest there be a decorating category for children and adults. She also recommended the City get an earlier start through Reach Alert.

Regarding the shrub removal at the City entrance sign at Bunsen Parkway, she was told it should be complete by the end of this month.

Commissioner Nichols advised she called 311 concerning the installation of a 'yield' sign on Stony Brook Drive across from Blowing Tree Road.

Finally, she noticed that the NO LEFT TURN sign located at the median on Taylorsville Road and Hurstbourne Lane had been knocked down and was laying across the median. She called the State, and rather than reinstalling it at the original location, they chose to put it in the dirt on the right side of Hurstbourne Lane.

Police

Commissioner Renninger thanked
Commissioner Bohnenkamp for her help in
checking on an elderly resident during a power
outage. It was also reported that on one Sunday
morning, a girl was knocking on doors in the City.
Since there was no officer on duty at the time, JTown was contacted, and they dispatched an
officer to drive around the City looking for her.

OLD/NEW BUSINESS

Miscellaneous

Mayor McAllister advised that he has sent the necessary paperwork to Treasurer Bloomer to get himself bonded as discussed in prior meetings.

Regarding an auditor for the City, a list of potential persons has been provided by Treasurer Bloomer to the Mayor. He has made some phone calls, but no one has been secured yet.

Lastly, a fence permit application was received for the house located at 9114 Hurstbourne Lane. After a review by the Commission, the fence construction was approved. The clerk was directed to contact the owner to advise of the City's decision.

There being no further business or discussion, the meeting was adjourned.
