I'm sure all of us have seen the reports of the winter weather that has been hitting the northern states and realizing that our turn is coming. So now is a great time to make sure your vehicle is ready for winter weather. At a minimum you should check your battery, anti-freeze levels, tire tread depth, windshield wipers and fluid, and make sure your heater and defrosters are working properly. Winter is hard on vehicles and breaking down in cold weather is no fun at all. It's also a good idea to put some blankets or additional winter clothing in your vehicle just in case.

Typically, there is also a spike in vehicle thefts during cold weather. It only takes a moment for someone to jump in an unattended vehicle that is warming up and drive off. Make sure you lock your vehicle while it is warming up and always keep it in sight to deter thefts. Kentucky Statute does prohibit leaving a running vehicle unattended. Also, make sure your windshield and windows are properly cleared of snow and ice before you start driving. Driving your vehicle while the windshield/windows are obscured is not only very dangerous it is also a violation of Kentucky Statutes and can result in a charge of Reckless Driving. The Officers of the Hurstbourne Acres Police Department wish all our residents a safe and happy 2023.

While completing the report in your vehicle, you noticed that there was a disturbance occurring near the bus. While investigating the disturbance, you discovered a male subject attempting to enter the bus while loudly threatening the bus driver. You physically pulled the subject back from the bus door and then realized that he was armed with a knife. You then took the subject at gunpoint and verbally challenged him. You were then able to take the suspect into custody without further incident. Your quick and decisive actions likely prevented a serious assault on the bus driver and a potentially dangerous and harmful situation for the dozens of elementary aged students on the bus.

Your actions bring great credit to yourself and this department. Keep up the great work.

# 9 Home Security Tips

Employing and engaging in some basic best practices around home security is the first step to help create a secure environment for your loved ones and family.

Consider these tips to help keep you, your family, and your possessions, safe and secure:

- Landscape with safety in mind. As you walk around your property, look for areas that could be potential hiding spots for thieves, who prize the privacy they provide. Try and clear away any overgrown areas.
- 2. Talk with your local police department.
- Know your neighbors. Take the time to meet them
- 4. Lighting matters. Lighting can set the right ambiance inside your home, but outdoor lighting can be the difference between your home being targeted or not by thieves. Motion-sensitive fixtures can help add security and provide light when needed. Also consider using automatic timers or a smart lightbulb that can be controlled remotely to turn lights on and off in various parts of the house.
- 5. Avoid advertising that shopping spree. Thieves look for and steal newly-delivered boxes on your front porch, a method called porch pirating, so consider having them delivered elsewhere or requiring a signature for delivery. Thieves may also look at clues provided by your trash or recycling, which may indicate the new computer or flat-screen television inside.
- Set a safety routine. Make sure you establish a routine where you regularly lock

- all doors, shut windows, and turn on your alarm system every time you leave your home. Avoid leaving spare keys outside, as thieves know most of the potential hiding places.
- 7. **Manage visibility.** Make sure you can see who is at your front door without opening it. Avoid placing valuables where they will be visible from the street.
- 8. **Protect your outdoor valuables.** Burglars also target sheds, garages, and other outdoor buildings. Secure your grill, lawn mower, bicycles, and other outdoor gear.
- 9. Create a plan for when you are away. Hold your mail, stop your papers, and ask a friend or neighbor to remove flyers from your property. Arrange for snow removal and lawn mowing so you do not advertise when you are away from home.

### **Attorney's Report**

Lastly, there was no update on the sidewalk situation on Blowing Tree Road.

### **COMMITTEE REPORTS**

### Park

Commissioner Eskridge advised that for the upcoming City Holiday Party on December 17<sup>th</sup>, all the plans are ready to go.

Lastly, this month the playground safety check list will be completed.

Also, the flag in the Park is checked annually.

Commissioner Nichols had concerns about keeping the Christmas Tree in the Park adequately protected off season. She spoke with Commissioner Eskridge and has offered to provide storage in her garage for the extra items acquired this year.

### Sanitation

Commissioner Bohnenkamp advised that it has generally been quiet. She confirmed that live Christmas trees will be picked up by EcoTech up until two weeks after Christmas.

A resident asked Commissioner
Bohnenkamp about whether EcoTech had been contacted about the trash can on Blowing Tree
Road. She has talked with EcoTech but will contact one more time to get the issue resolved.

### Streets

Commissioner Nichols contacted Modern Vascular about the problem with vehicles not stopping when exiting the parking lot. They were unwilling to have a *stop bar* painted next to the stop sign already there. Commissioner Nichols expressed a concern about some trees along Hurstbourne Lane near the intersection at Hurstbourne Parkway. Mayor McAllister stated he remembers an ordinance requiring Hagan Properties to maintain the trees along Hurstbourne

Lane. Some trees might be blocking the view of oncoming cars toward the intersection at Hurstbourne Parkway. He said he would check the old ordinances and confirm.

In other news, Commissioner Nichols said the Holiday decorations have been put up around the City. She thanked resident Kim Bloomer for her part in the decorations this year and Perry and Kaelin Landscaping and Maintenance for the actual installation of the decorations.

### **Police**

Commissioner Renninger said the City of Hurstbourne Acres received a thank you note from the Brown Family for the thoughts and prayers from residents regarding Kay Brown and the planting of a tree in her memory.

## Old/New Busines

### **Zoning Meeting**

Mayor McAllister advised there is a zoning meeting on December 19th regarding the old Schumann Antiques building and approval for the installation of an outside elevator.

### **Swearing In Ceremony**

Attorney Cato completed the swearing in of the newly elected city officials.
