# **Police**Chief Steve Griffin

I would like to take the opportunity to reiterate how to contact the police department if you need assistance. The Hurstbourne Acres Police Department is not funded for 24/7 operation. We currently are budgeted for approximately 610 hours of the 720-744 hours each month so unfortunately there are approximately 12-15 shifts each month when we do not have an officer working. During these shifts any calls for police services would be handled by LMPD so if you need assistance and cannot make contact with a Hurstbourne Acres Police Officer, please contact the Jefferson County Sheriff Dispatch number listed below, and the appropriate services will be dispatched to serve you.

911: Call 911 immediately if it is an emergency situation

HURSTBOURNE ACRES POLICE CELL PHONE (502) 553-7318: This is the best way to contact us.

Any Officer working will have this phone with them. If you do not get an answer at this number either no Officer is on shift or they are tied up with another call for service. Please note that we do not return calls if you do not leave a message due to the high volume of spam calls we receive.

HURSTBOURNE ACRES CITY HALL OFFICE PHONE (502) 499-2352: This phone is not monitored because Officers are normally out of the office patrolling the city. We check the answering machine when we get back to the office and will return your call if you leave a message. Please note that we do not return calls if you do not leave a message due to the high volume of spam calls we receive.

JEFFERSON COUNTY SHERIFF DISPATCH (502) 574-5400: This is the best number to call for non-emergency service requests if you cannot reach us directly on the Hurstbourne Acres Police Cell Phone. This phone is monitored 24/7 and they will contact us directly via radio or dispatch the appropriate agency to assist you if we do not have an Officer working.

The street lights that are in our City are leased from LG&E and have been since their installation many yeas ago. Included in this lease, they will replace light bulbs and globes when needed and repair pole damage.

LG&E has worked with AT&T and Spectrum at the end of Bristol to install boxes for cable, I am told. I spoke with my street light contact person at LG&E today, 4/20, and was told that it would be another 2-3 weeks before this could be finished, which means no street light at the end of Bristol until then. Since LG&E owns these poles, that is their prerogative, even though it causes a total blackout for our residents at that location.

## **Public Comments**

Resident Jim Lynch expressed his concern about the removal of trees/bushes behind his

house. He said there needs to remain a certain amount of foliage to act as a sound barrier from

Hurstbourne Parkway and Bunsen Parkway. Secondly, he noted that the EcoTech trucks

continue to leak and create stains on the city streets. Mayor McAllister advised that he will be

attending a meeting shortly and said he would ask Mayors in other cities how they handle leaks

from service trucks. Lastly, resident Mike Hess mentioned that there are several trees down on

the berm next to the Park. Since the City does not own the berm, the owners of the properties

need to be contacted so that the maintenance, like removing the dead trees, can be performed.

## **COMMITTEE REPORTS**

Park

Commissioner Theiss acknowledged that several trees on the Bunsen Parkway berm need

to be removed and new trees planted. In other news, ten

new picnic tables will be delivered on May 2, and the existing picnic tables disassembled and removed. The Easter Egg Hunt was a success again this year. Finally, the city-wide yard sale will be held on May 27 with an ad placed in the Courier/Journal along with other social media sites.

#### Sanitation

Commissioner Eskridge advised that there will be a tree giveaway at Joe Creason Park this Saturday for residents of Jefferson County. The limit is three per household. It was suggested that if you don't personally need a tree, please pick some up and donate them to the Park. The Brightside Community Clean-up for Hurstbourne Acres participation is being rescheduled for May 20. There was a problem with trash pickup this week along with backdoor service. It was noted that our City will be putting the trash and recycling contract out for bid.

#### Streets

A resident advised that the one-way sign on Blowing Tree Road is missing.

Commissioner Nichols will be given additional information so that she knows how to proceed with the installation of a new sign.

#### Police

Commissioner Renninger issued an ABC license to Chuck E Cheese. In other news, she has sent a letter to the 'dot gov' website to get a new website and e-mails set up for our City.

Our Police Department has excess money in the current budget. Commissioner Renninger is asking for approval to offer time and a half to our officers for the open spots on Friday, Saturday and Sunday. After a discussion, Commissioner Theiss made a motion to approve the spending as requested. Commissioner Eskridge seconded the motion which carried unanimously.

## **Executive Session**

There being no further business or discussion, Commissioner Eskridge made a motion to recess the meeting to go into an executive session to discuss the PuppyGram situation. The motion was seconded by Commissioner Theiss and carried without opposition. Once the executive session is complete, the regular meeting will be rejoined and then adjourned.
